Control of inside information

The Company set up the rules and regulation for the inside information usage as follows:

1. Determine rules and regulations for the inside information usage in accordance with good corporate

governance as follows:

(1) Director, executive, employee and staff has to keep the Company's secret and/ or inside information.

(2) Director, executive, employee and staff will not use both directly and indirectly any secret and /or inside

information to disclose or exploit for personal or other benefit with or without any return.

(3) Director, executive, employee and staff will not trade, transfer or receive shares of the Company by

using secret and/or inside information and/ or entering into any legal agreement by using secret and/ or

inside information which will cause directly or indirectly damage to the Company. Director, executive,

employee and staff who work in department which obtain insider information should avoid or cease

trading the Company's share during 1 month before the financial statements disclose to the public. This

prohibition governs spouse and minor child of director, executive, employee and staff of the Company.

Any person who breaches the regulations will be counted as severe violation.

(4) Director and executive including the Company's auditor has to report the change of shareholding, such

holding has to include the shares hold by the spouse and minor child, to SEC according to Section 59

of the Securities and Exchange Acts B.E. 2535.

2. Announce such rules and regulations for widespread acknowledgement.
